The Government of Nepal **has allocated funds** from **GoN** towards the cost of **Construction of konjyosom rural municipal office building** and intends to apply part of the funds to cover eligible payments under the Contract **for konjyosom rural munic./OB/W/NCB/09/76/77**. Bidding is open to all eligible as per Section V of bidding document..
2. Konjyosom rural municipality invites electronic bids from eligible bidders for the **Construction of konjyosom rural municipal office building** under National Competitive Bidding – Single Stage Two Envelope Bidding procedures.

Only eligible bidders with the following key qualifications should participate in this bidding:

- Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: **[NRs 37797983]**
 - Minimum Work experience of similar size and nature: **building projects with value of minimum Nrs 34200000**
3. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding Document.
 4. Eligible Bidders may obtain further information and inspect the Bidding Documents at the office konjyosom rural municipality ,email:konjyosom2075@gmail.com or may visit PPMO e-GP system www.bolpatra.gov.np/egp.
 5. Bidder should submit their bid electronically may download the bidding documents for e-submission from PPMO's e-GP system www.bolpatra.gov.np/egp. Bidders, submitting their bid electronically, should deposit the cost of bidding document in the Project's Rajaswa (revenue) account as specified below .

7. electronic bids must be submitted through PPMO's e-GP system www.bolpatra.gov.np/egp **on or before 12:00** on **10-dec-2019**. Bids received after this deadline will be rejected.
8. The bids will be opened in the presence of Bidders' representatives who choose to attend at 14:00 on **10-dec-2019**. at the office of konjyosom rural municipality ,chaughare,lalitpur ,Bids must be valid for a period of **90 days** after bid opening and must be accompanied by a bid

security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of **NRS 1130000** which shall be valid for 30 days beyond the validity period of the bid .

9. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
